AXLE CONTINGENCY

April 12, 2000

CONTINGENCY REQUIREMENTS:

VEHICLE MUST HAVE:

A) MW HI-TORQUE FLANGE AXLES AND CONTINGENCY DECALS AFFIXED TO BOTH SIDES OF THE RACE CAR THROUGHOUT THE ENTIRE EVENT.

OR

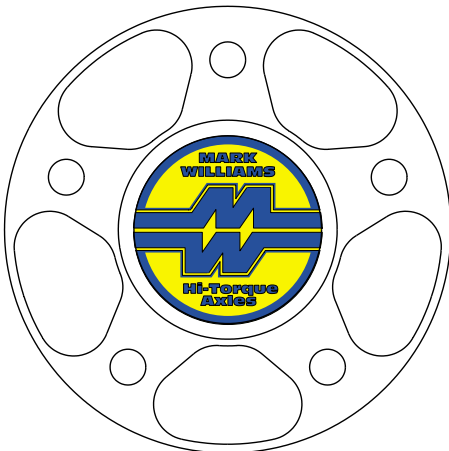
B) MW MASTERLINE FLANGE AXLES AND CONTINGENCY DECALS AFFIXED TO BOTH SIDES OF THE RACE CAR THROUGHOUT THE ENTIRE EVENT.

OR

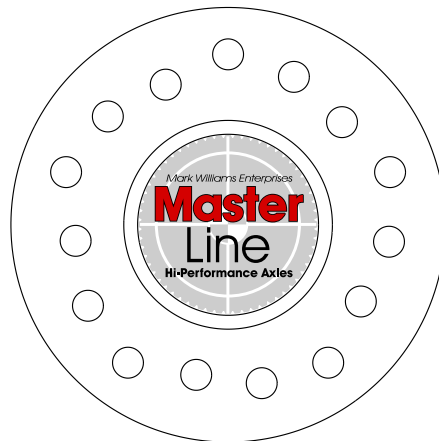
C) A MW COMPLETE FULL FLOATER ASSEMBLY AND CONTINGENCY DECALS AFFIXED TO BOTH SIDES OF THE RACE CAR THROUGHOUT THE ENTIRE EVENT. A FULL FLOATER ASSEMBLY CONSISTS OF THE FOLLOWING PARTS: HUBS, SPINDLES, BRAKE CALIPERS, ROTORS, DOUBLE SPLINE AXLES, DRIVE PLATES, AND COVERS. THE USE OF MW FLOATER SHAFTS WITH OTHER MANUFACTURERS HUB ASSEMBLIES DOES NOT MEET OUR CONTINGENCY REQUIREMENTS.

VISUAL VERIFICATION OF FLANGE TYPE AXLES:

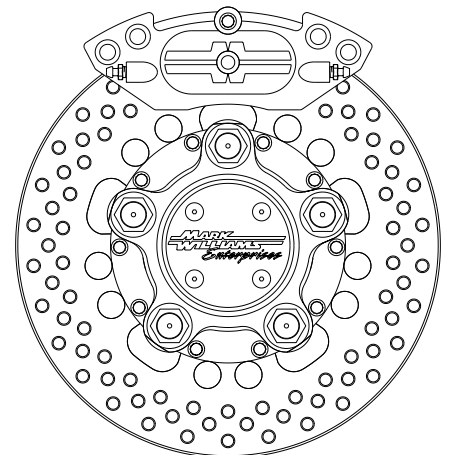
FLANGE TYPE AXLES MUST HAVE MW NAME PLATES ATTACHED. THE AXLE NAME PLATES MUST BE CLEARLY VISIBLE THROUGH THE WHEEL CENTERS. AS A RESULT, WHEEL CENTER CAPS MAY NOT BE USED.



MW Hi-Torque axle flange with name plate. Name plate has a yellow background and a blue foreground.



MW MasterLine axle flange with name plate. Name plate has a gray background and a red and black foreground.



MW full floater assembly with cover plate. Cover plate has a blue anodized background and a silver foreground.

VISUAL VERIFICATION OF FLOATER ASSEMBLIES:

FULL FLOATER ASSEMBLIES MUST HAVE MW ENGRAVED BLUE ANODIZED DRIVE PLATE COVERS ATTACHED. THE DRIVE PLATE COVERS MUST BE CLEARLY VISIBLE THROUGH THE WHEEL CENTERS. AS A RESULT, WHEEL CENTER CAPS MAY NOT BE USED. IN ADDITION TO THE DRIVE PLATE COVERS, VERIFICATION INCLUDES THE PRESENCE OF MW LOGOS CAST INTO THE BRAKE CALIPERS.

AXLE CONTINGENCY

DECAL DISPLAY :

1) MARK WILLIAMS AXLE DECALS MUST BE DISPLAYED ON BOTH SIDES OF THE RACE CAR THROUGHOUT THE ENTIRE RACING EVENT. DECALS ARE AVAILABLE AT THE MW DISPLAY AT NATIONAL EVENTS OR BY REQUESTING DECALS FROM MARK WILLIAMS ENTERPRISES, INC 1-800-525-1963. PAINTED REPRODUCTIONS OF MW DECALS ARE NOT ACCEPTABLE.



Hi-Torque axle decal has a yellow background and a blue foreground.



MasterLine axle decal has a gray background and a red and black foreground.

PRODUCT CONFORMATION & PAYMENT DISTRIBUTION:

1) AFTER MARK WILLIAMS ENTERPRISES RECEIVES THE EVENT WINNER SHEETS, RACERS WILL BE SENT A PRODUCT VERIFICATION FORM. COMPLETION OF THIS FORM, INCLUDING SERIAL NUMBER SUBMISSION, IS REQUIRED IN ORDER TO RECEIVE PAYMENT (SERIAL NUMBERS ARE LOCATED ON THE SPLINED END OF THE AXLE SHAFT). UPON RECEIVING THE COMPLETED VERIFICATION FORM, MW WILL CONFIRM THAT ALL CONTINGENCY REQUIREMENTS HAVE BEEN MET AND THEN SEND OUT A PAYMENT CHECK.
